NOTICE OF STATEWIDE RECORDING FEE CHANGES DUE TO LEGISLATIVE ACTION

Effective October 17, 2019, statewide recording fees for most documents will increase by \$6.00 due to the enactment of HB 166 state budget legislation. The new recording fee for the first two pages will be \$34.00 (previously \$28.00). Each additional page remains the same as current law at \$8.00. Half of all recording fees collected are required to be submitted to the state to the credit of the Ohio Housing Trust Fund.

Effective Date October 17, 2019
